Minutes of the Parish Council Meeting held on Wednesday 11th March 2015 At 7.30pm in Arkendale Community Hall

2014.100 Apologies – HBC Cllr Anthony Alton

2014.101 Declarations of Interest – 2014.110 –Cllr Houseman in relation to letter dated 3rd March 2015

regarding a possible breach of planning control at Holgate Bridge Farm, Arkendale

2014.102 Public Participation – Cllr Topham welcomed the members of the public

2014.103 Minutes of the Previous Meeting

The minutes of the meeting held on Wednesday 14th January 2015 were approved as a correct record and signed by the Chairman.

2014.104 Reports from other Councillors

Cllr Topham (on behalf of Cllr Alton) reported that the new council building in Harrogate has been approved by HBC planning department and will be presented for approval by NYCC later this year in July/Aug

Cllr Windass reported on matters from NYCC

Council tax – a 1.99% increase has been approved by NYCC

Potholes – NYCC have been given an amount by central government to repair the roads **NYCC budget** – there are still issues regarding cuts and shortfalls, in particular libraries and grass cutting and school buses. Clerk to find out whether the grass cutting for Coneythorpe village green will be affected

Taxis – there was a recent request to increase fares to out of town areas. This has not been agreed by NYCC

Planning – the application for development at Flaxby is expected to be submitted shortly. The planners have a duty to consult on infrastructure but have no powers to dictate. The new build housing requirement is still being assessed but is likely to be lower than originally suggested by the Government Inspector. Planning has been approved for Manse Farm.

Cllr Topham thanked Cllr Windass for his report and invited him to report on the AWRP community liaison group committee meeting.

2014.105 AWRP Community Liaison Group

Cllr Windass confirmed that he has been elected as chairman of the group. A new access route to the site has been agreed. A sum in the region of £800,000 has been allocated by Amey Cespa for communities within 3.5 km of the site to go towards mitigation and Cllr Windass has requested a map to show which communities will benefit. Cllr Windass agreed to help with liaison between the residents of Clareton and Amey Cespa regarding landscaping requirements.

2014.106 The Bluebell

Elizabeth Owen and Gareth Mann (Manager of the Bluebell) confirmed that the Bluebell will be officially open to the public on Thursday 26th March and that local residents in Arkendale and Coneythorpe are invited to a preview on Wednesday 25th March. (Post meeting note:- invitations will be hand delivered by Elizabeth Owen to residents). Signage is being agreed and the licensing hours will be standard for this type of venue.

2014.107 Finance

- 1. Payment of £92.08 clerk's salary (Jan 2015)

The current financial position of the Parish Council was reviewed.

Cllr Bailey to reconcile all cheque stubs against the entries in the financial review spreadsheet for the year to date

The Parish Council's schedule of assets was reviewed and amended to include the bench seat and pump in Arkendale at a value of £300.00

The Parish Council's Risk Assessment and Management paper was reviewed and agreed without amendment except clerk to check membership of SLCC

Cllr Topham reported that a pension scheme is being set up on behalf of the clerk. It is unlikely to involve any contributions being made but it is compulsory to set up. Cllr Topham confirmed that he has been appointed as point of contact to the pension regulator and that the staging date is 1st February 2017,

Cllr Topham reported that Autela will be applying a small increase in charges for managing the payroll from 1st April 2015. This was agreed.

2014.109 Planning Applications dealt with between meetings

Dale Farm, Arkendale ("the Property") – Parish Council's consent sought for the relocation of the decommissioned village phone box on Moor Lane to make way for a new access to the Property. After hearing reasons for the relocation by the owner of the Property and taking into account the risk of damage to existing trees if the relocation didn't go ahead, it was unanimously agreed by all Councillors that the relocation of the phone box could go ahead subject to the owner of the Property making good any damage to the phone box and carrying out moderate decoration to smarten up its appearance.

2014.110 Planning applications received - post agenda, pre meeting

Planning Enforcement Case No 15/00103/PR15 – possible breach of planning control at Holgate Bridge Farm, Moor Lane, Arkendale – noted

2014.111 Commuted sums

Cllr Topham provided an up to date spreadsheet.

- Church lighting Cllr Houseman to obtain a quote from Tony Brown Electrical
- Church bench Cllr Shipman presented a quote from Harewood Bridge Sawmills dated 6th February 2015 for a new bench for the cemetery of £200 including VAT. Cllr Topham agreed to apply for this sum from commuted sums. Clerk to apply.
- Coneythorpe village sign Cllr Topham referred to a quote from HACS of £1559.30 exc VAT. It was agreed that this is too expensive and there are insufficient commuted sums to cover this (we have £884.80 allocated to amenity green space). Cllr Topham to seek a new quote. NB. the Parish council have already agreed to apply for commuted sums to pay for the sign.

2014.112 Arkendale Memorial Hall

Alan Stokes gave the following report

- Attendance for films has been increasing
- Wine Society to hold an event this month proving to be popular
- Betty's of Harrogate have kindly donated a new coffee machine with flasks
- Fibre optic broadband is now available in the hall

2014.113 Harrogate District Local Plan – Workshop

Cllr Shipman reported on the recent workshop held on Wednesday 4th March.

- The aim of the workshop was to provide an opportunity for local Parish Councils to contribute to the development of the Local Plan
- A submission to protect green spaces in the villages will be required by June 26th 2015. Green spaces will be protected if evidence is collated as to usage, amenity, wildlife and other criteria
- Cllr Topham is to collate information on Coneythorpe and Cllr Shipman is to collate information on Arkendale, by the end of March.
- Residents can register to receive updates on the Local Plan process on http://consult.harrogate.gov.uk
- Suggested green spaces were The Marr and Clare How Close in Arkendale. Cllr Topham to check whether Coneythorpe village green will require protection.

2014.114 Coneythorpe

- Speed restrictions Cllr Robertshaw will continue to chase Area 6 regarding rumble strips or other traffic calming measures
- HGVs HBC have confirmed that the enforcement investigation at Clareton Moor Farm has
 not revealed a material change of use. Cllr Topham has spoken to Mr Gill and it has been
 agreed that the HGVs will keep to a 20mph speed limit through Flaxby and Coneythorpe and
 that Mr Gill is monitoring this. Cllr Savage has confirmed that there is no breach of the weight
 limit on the roads. A concern was raised regarding some of the HGVs mounting the kerb onto
 the village green. Clerk to contact HBC.

- Derelict building HBC have written to Mrs Bulmer requiring certain repairs and maintenance to be carried out to Ivy Cottage and The Old Forge.
- Footbridges on Knaresborough round Highways Authority have agreed to a replacement.

2014.115 Arkendale

- Dead tree on Clare How Close a works order has been issued by HBC and the work should be carried out in March Clerk to chase
- The junction at the Mar Cllr Robertshaw reported that 95 Alive have monitored speed and the average is 34/35 mph. No further action required.
- Rotten road signs Cllr Robertshaw has reported that the sign on Clare How Close has been repaired. The signage near the pub is being restored. No further action required.
- Children's play area Cllr Robertshaw is liaising with a group at Burton Leonard
- No parking signs on Clare How Close this has been referred to the relevant department at HBC. Clerk to chase.
