2015.77 Minutes of the previous meeting:

Cllr Shipman to organise an interim meeting of the Parish Council and the public to review the plans for both developments

2015.88 Commuted Sums

- Benches at Clare How Close and in the cemetery Cllr Shipman was pleased to report that the benches have been installed and the money has been reimbursed by community sums
- Church lights the cost of flood lights cannot be met by commuted sums. The timer needs repair. There will be no further action by the Parish Council on this point
- Vestry light a light is required for health & safety reasons. Cllr Shipman referred to the quote from H Glover for £144 inc VAT. Cllr Topham proposed that the sum be given as a grant from the Parish Council. All Cllrs agreed.

2015.89 Community Hall, Arkendale

Alan Stokes reported on future events to be held in the Community Hall

2015.90 Coneythorpe

- Broadband update access to superfast broadband was installed in December 2015
- 20 mph signs Cllr Robertshaw is organising an action group and a proposal will be put forward at the village AGM.

2015.91 Arkendale

- The Marr Cllr Bailey reported that there are some objections from local residents to changing
 the current condition of the Marr. There may be ecological objections too. Cllrs Bailey and
 Houseman to canvass opinions from local residents and to make enquiries at HBC regarding
 the ecological issues
- Children's play area Cllr Robertshaw said that this project is to be put on hold as it is unlikely to be considered for a grant from Two Ridings
- Installation of mirror for the Community Hall Cllr Robertshaw explained that this project would not be supported by NYCC.Cllr topham confirmed that as a result, the Parish Council will not be able to carry forward with this project
- The Blue Bell Cllr Shipman reported complaints about the lighting from a resident which has now been reported to the Blue Bell. If the problem continues then HBC and Richard Sykes will

be informed. The smell from the extractor fan has been reported to Richard Sykes and he has acknowledged that it is not working properly and he will take action

2015.92 Queen's 90th birthday celebrations

 Cllr Topham reported on an email dated 20th December 2015 from YLCA containing suggestions on celebrating the Queen's birthday – official birthday in June and beacons on 21st April. It is open to either village to organise - Coneythorpe village to discuss at the village AGM

- Cllr Topham suggested this take place on 19th March for Arkendale and 20th March for Coneythorpe. All Cllrs agreed. Clerk to order equipment
- Grit bins the empty grit bin on Clareton Lane was reported

 Cllr Robertshaw reported on recent repairs. Further potholes were reported on the road between Flaxby and Coneythorpe and at Wilsons farm towards Ferrensby

 Cllr Houseman has cleared the fly tipping on Spitlands Lane. More was reported in the same place
